ENTRY AGREEMENT: By entering and signing this entry blank, and on behalf of myself and my participants, guardians, representatives, employees and agents, I AGREE to release and hold harmless Rolling Rock Farm, LLC AND OFEA and their officials, directors, volunteers, agents and employees for any action. I represent that I am eligible to enter and/or participate under the rules of the Competition, and every horse I am entering is eligible as entered. This document waives important legal rights. Read it carefully before signing. I AGREE in consideration for my participation in this competition ("Competition"), which is managed by Rolling Rock Farm LLC AND OFEA to the following: I AGREE the construction and application of Rolling Rock Farm, LLC AND OFEA rules are governed by the laws of the State of Oregon, and any action instituted against Rolling Rock Farm, LLC AND OFEA must be filed in the State of Oregon. I AGREE that Rolling Rock Farm, LLC AND OFEA as used herein includes Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, and volunteers. I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, handler, lessee, owner, agent, coach, trainer, or as parent of guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherit dangerous risks of accident, loss, and serious bodily injury including but not limited to broken bones, head injuries, trauma, pain, suffering, or death. ("Harm"). I AGREE to hold harmless and release the Rolling Rock Farm, LLC AND OFEA and Competition Management from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results resulted, directly or indirectly, from the negligence of the Competition. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I ACKNOWLEDGE that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and I AGREE to all of the above provisions and I AGREE to assume all of the obligations of this Release on the child's behalf I represent that I have the requisite training, coaching and abilities to safely compete in this Competition.
